Avoid formation of dust and aerosols. Ensure adequate ventilation. Evacuate personnel to safe areas. Avoid breathing dust, vapors, mist or gas.

6.3 Methods and materials for containment and cleaning up

In case of a spill or a release, take precautions to minimize worker exposure. For spills onto surface areas, use at least a 0.5% sodium hypochlorite solution, and pour onto the contaminated surface allowing for at least thirty minutes of contact and then wipe dry. Autoclaving may be applied to contaminated material which is in solution or to which the autoclave steam has access. Autoclaving at ≥121°C, ≥15 psi in a validated cycle will render the product safe.
