6.3 Methods and materials for containment and cleaning up

In case of a spill or a release, take precautions to minimize worker exposure. For spills onto surface areas, the contaminated surface should be thoroughly sprayed or rinsed for at least five minutes with at least a 0.5% sodium hypochlorite solution, then wiped dry. Autoclaving may be applied to contaminated material which is in solution or to which the autoclave steam has access. Autoclaving at $\geq 121^{\circ}$ C, ≥ 15 psi in a validated cycle will render the product safe.
